## 1 Process

When creating your IPAFFS declaration for wild caught fishery products which require catch certification you will need to add **ALL of the IUU information** (including the documents) to the CHED-P declaration.

This is done under the **'Documents'** section of the CHED-P declaration.

### Catch certificates

You must add catch certificates for all fish species unless they are exempt from illegal, unreported and unregulated (IUU) fishing controls.
